- ✓ Enclose a self-addressed, stamped envelope for an acceptance letter
- ✓ Include a check payable to THUNDER BAY ARTS COUNCIL, Inc.

- Letters of acceptance will be issued by May 15, 2027
- Entry fee and photographs will be returned to rejected applicants
- Once accepted, the fee is **NONREFUNDABLE**
- There will be no rain date or indoor facilities in case of inclement weather
- No hawking, raffles, “sales” signs, pets, “buy-sell” items or generators
- The Art on the Bay Committee reserves the right to refuse any entry or withdraw any product or vendor from the exhibition at its discretion
